# **ENTRY CONDITIONS**

# TO QUALIFY FOR ENTRY, YOUR INNOVATION MUST MEET THE FOLLOWING CRITERIA

- ▶ Be a product or service launched on the market **strictly no more than two years ago (01/06/2022)** and already available.
- > Be on show at the exhibition

The competition is open to French and international companies. Registration files must be submitted in English or French only.

# **JUDGING CRITERIA**

A PANEL OF PROFESSIONALS COMPRISING JOURNALISTS, EXPERTS, INSTITUTIONAL REPRESENTATIVES, AND CURRENTLY ACTIVE PROFESSIONALS WILL JUDGE YOUR ENTRY ON THE FOLLOWING CRITERIA:

- Disruptive or ongoing innovation in the French market
- Product support guarantee
- Ease of implementation
- Product reliability: R&D results

- Implementation cost/ROI
- Measurable benefit to the operator
- Solution meeting the needs of many users

# **CONTEST RULES**

### **ARTICLE 1**

GL events EXHIBITIONS OPERATIONS, in the scope of the Expobiogaz 2024 gathering in Strasbourg on the 5th and 6th June, 2023, is running a contest called the 2024 EXPOBIOGAZ INNOVATION AWARD ("Trophée de L'innovation Expobiogaz 2024").

### **ARTICLE**

The competition is open only to exhibitors and only for products or product ranges on show at the exhibition that came onto the market on or after 1st June, 2022.

### **ARTICLE 3**

The 2024 Innovation Award trophy will go to the best performing innovation. The products shortlisted by the judging panel will be on show on the contestants' stands on 5th and 6th June, 2024.

### **ARTICLE 4**

The main judging criteria for attribution of the Award are disruptive or ongoing innovation on the French market, product support guarantee, ease of implementation, product reliability (R&D results), implementation cost/ROI, measurable benefit to the operator, qualification for financial aid schemes, and the solution's ability to meet the needs of many.

### **ARTICLE 5:**

Each competitor must provide the panel with a complete-as-possible entry appraisal file on the product or service. Your application will not be considered if it does not include this file and the associated documents. These must reach GL events Exhibitions Operations no later than the strict deadline of 5th April, 2024. ARTICLE 6:

The judging panel comprises representatives of professional institutions in the biogas sector and in research, exhibition partners, and journalists from the specialist trade press. The judges' decisions

are theirs alone and are final.

The panel examines the entries in a day of deliberation and draws up a shortlist. Where necessary, the panel will examine the shortlisted entries on the stands during the show before proceeding to elect the winner.

### **ARTICLE 7**

Products that have won an award in a previous contest are not eligible for entry.

### **ARTICLE 8**

The Expobiogaz Award trophy will be presented at the Expobiogaz 2024 trade show. All shortlisted companies solemnly undertake to have a representative at the Award ceremony.

### **ARTICLE 9**

The judges reserve the right to withhold the Award or cancel the contest where appropriate.

### **ARTICLE 10**

The events leading up to and after the 2024 Expobiogaz Award are exploited across all media. The winner may exploit the winner's title in all their product communications (advertisements, sales literature, etc.) as long as it includes a clear reference to the Expobiogaz 2024 trade show. The "Expobiogaz" and "Trophée Expobiogaz" logos will be provided to the winner for this purpose.

# **ARTICLE 11**

Participation in the competition is taken as the contestant's full and unconditional acceptance of these rules.
